CA SYSVIEW Option for CICS is an integrated CICS performance monitoring and management tool that is available with CA SYSVIEW® Performance Management (CA SYSVIEW). CICS metrics are displayed at the system, transaction, and program-detail level, in real-time or historical mode.

The CA SYSVIEW Option for CICS allows you to proactively monitor and gain SYSPLEX-wide detail and historical insights into your CICS environment. To gather these insights, CA SYSVIEW installs a data collector inside each CICS region of interest, resulting in deeper insights into CICS region performance and availability, along with transaction performance and rates. Being tightly coupled with CICS also allows CA SYSVIEW to directly modify CICS resources; for example, canceling a transaction, closing a file, or deleting temporary storage queues.
